WARRANTY

Milsco Manufacturing, a Unit of Jason Incorporated, ("Jason") warrants to the original purchaser ("Buyer") that its Products will be free from material defects in workmanship and materials under normal use and service for a period of 90 days from the date of Jason's delivery of Products (the "Warranty Period"). There is **NO WARRANTY** in cases of damage in transit, negligence, abuse, abnormal usage, misuse, accidents, normal wear and tear, damage due to environmental or natural elements, failure to follow Jason's instructions or improper installation, storage or maintenance. This warranty does not cover parts furnished but not produced or manufactured by Jason, and Jason's sole obligation with respect to such parts shall be limited to assigning or transferring to Buyer any written warranty extended to Jason by the manufacturer of such parts to the extent such warranty may reasonably be assigned or transferred. However, Jason does not adopt, guarantee or represent that the manufacturer will comply with any of the terms of the warranty of such manufacturer.

Jason's sole and exclusive obligation under this warranty (and Buyer's sole and exclusive remedy) shall be, upon prompt written notice by Buyer during the Warranty Period of any defect, to either, at Jason's option, repair or replace without charge, F.O.B. Jason's facility, any defective Product or part thereof expressly warranted herein by Jason against defects and found by Jason in its sole discretion to be defective and covered by this warranty or credit Buyer for the purchase price paid for such Product or part. **JASON SHALL NOT BE LIABLE TO BUYER, OR TO ANYONE CLAIMING UNDER BUYER, FOR ANY OTHER OBLIGATIONS OR LIABILITIES, INCLUDING, WITHOUT LIMITATION, OBLIGATIONS OR LIABILITIES ARISING OUT OF BREACH OF CONTRACT OR WARRANTY, NEGLIGENCE OR OTHER TORT OR ANY THEORY OF STRICT LIABILITY, WITH RESPECT TO THE PRODUCTS OR JASON'S ACTS OR OMISSIONS OR OTHERWISE.** This warranty covers only replacement or repair of defective Products or parts thereof at Jason's facility and does not include the cost of field service travel and living expenses, labor, inspection, removal or installation of new Products or parts or normal maintenance.

IN NO EVENT SHALL JASON BE LIABLE FOR INCIDENTAL, COMPENSATORY, PUNITIVE, CONSEQUENTIAL, INDIRECT, SPECIAL OR OTHER DAMAGES. JASON'S AGGREGATE LIABILITY WITH RESPECT TO A DEFECTIVE PRODUCT SHALL BE LIMITED TO THE MONIES PAID TO JASON FOR THAT DEFECTIVE PRODUCT.

Any assistance Jason provides to or procures for Buyer outside the terms, limitations or exclusions of this warranty will not constitute a waiver of the terms, limitations or exclusions of this limited warranty, nor will such assistance extend or revive the warranty. Jason will not reimburse Buyer for any expenses incurred by Buyer in repairing, correcting or replacing any defective Products, except for those incurred with Jason's prior written permission.

THE ABOVE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES (INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE). JASON HEREBY DISCLAIMS AND EXCLUDES ALL OTHER WARRANTIES.
